# Information and required documents for conclusion of balancing agreement with Amprion

This balancing group contract is the basis for the setup of balancing-groups in our control area. The balancing group contract is fixed by the Federal Network Agency (Az. BK6-06-013) with resolution from 29. June 2011.

If you consider a conclusion of balancing agreement please send us a formal business letter with indication of Energy Identification Code (EIC), the desired starting date and estimation of expected trading volume and/or end-user supply.

## Following documents are required:

- Current, legally attested copy of commercial certificate of registration / changes in directors / return of allotment
- o Completely fulfilled and signed annex 2 (Contact Data of the BRP) of balancing agreement

If your company does not have a central contact person for NePo yet, the registration for access authorization or a new registration can be requested at Amprion via email: nepo@amprion.net.

- Copy of the identity document for the legitimacy of the authorized signatory(s). Except for the signature and the name all data can be blackened. The copy of the ID or passport will be used exclusively for identification and will be permanently destroyed after conclusion of the contract
- In case the scheduling management and/or the MaBiS communication is carried out by a service-provider we need a Power of Attorney (in Original)

## **Energy Identification Code (EIC):**

In general the ENTSO-E Energy Identification Code (EIC) must be applied by the Local Issuing Office (LIO) of ENTSO-E in the country, where your company is registered. For foreign companies without an ENTSO-E (LIO) in their own country usage of BDEW (LIO) is possible.

### **Market Partner-ID:**

For the EDIFACT communication regarding the MaBiS-Process the balance responsible party (BRP) must indicate in the annex 2 (Contact Data of the BRP) the market partner-ID (MP-ID) in the role: **(Sub-) Bilanzkreisverantwortlicher**" or the ILN/GLN (International location Number/ Global Location Number).

After receipt of all required documents and information Amprion will send you the balancing agreement in hard copy form. Before the conclusion of balancing agreement Amprion will verify the credit rating of your company. Depending on this result Amprion can demand a bank guarantee with reference to point 14 of the balancing agreement. In this case, the setup of your balancing account will be only possible, after Amprion received the required guarantee.
