**FC group C:** The § 19 StromNEV levy for consumptions above 100,000 kWh/year in case the final customer either belongs to the manufacturing industry or is a rail-bound traffic or a railway infrastructure company and electricity expenses of the previous calendar year exceed 4 % of the total turnover is indicated in the table above. The fulfillment of these preconditions has to be confirmed by a chartered accountant.

**FC group C:** According to CHP law § 9 section 7 clause 3 the CHP surcharge for consumptions above 100,000 kWh/year is indicated in the table above in case the final customer is a manufacturing industry company, a rail-bound traffic company or a railway infrastructure company with electricity expenses of more than 4 % of the total turnover in the previous calendar year.

**FC group C:** The Offshore-liability-levy for consumptions above 1,000,000 kWh/year is indicated in the table above in case the final customer either belongs to the manufacturing industry and electricity expenses of the previous calendar year exceed 4 % of the total turnover. The fulfillment of these preconditions has to be confirmed by a chartered accountant.
